



# JOINT LETTER



*To States, civil society in Latin America and the Caribbean, indigenous peoples, people of African descent, multilateral organizations, international funding entities, and other actors whose decisions impact the region.*

CONFERENCIA REGIONAL DE DERECHOS HUMANOS

During the RegionaR 2022 Conference, more than 150 human rights organizations from Latin America and the Caribbean met in Bogotá, Colombia, convened by RegionaR/Regional Human Rights Forum in response to the urgency of reflecting on how we defend rights in the different and adverse contexts of our region.

We want to articulate: We are here to reaffirm our causes. We are here in defense of a dignified life, as a space of diverse, courageous, responsible voices. We are aware of the particular and general realities that affect us as a region, without fear of expressing ourselves and with a total willingness to assume the challenges that are necessary to unlearn, dialogue, and fully incorporate different approaches (feminist, ecocentric, non-patriarchal, decolonial, anti-racist, expressive of our diversity of indigenous peoples and Afro-descendant peoples, people differently abled, LGBTI communities, languages and identities, with a non-capitalist logic). We are here to propose routes of action that materialize the non-hegemonic universality of human rights, collective rights and environmental rights, as well as our right to defend rights and preserve dignity against any intention of setback that hinders the achievement of good living for all.

Human rights are in a state of crisis due to the advance of anti-rights, conservative groups, extractivisms, the resurgence of totalitarian movements, political violence, armed and organized crime, closure of space for civil society and constant attacks on human rights defenders, dismantling of the rule of law(s), as well as a setback in the recognition and guarantee of human rights, aggravated by the pandemic, which also increases forced migration. While this is occurring globally, we feel it especially in the region and, as civil society, our response has not been sufficient to address this context. The factors above continue to dismantle and disable our actions. However, it is our duty to voice our struggles for the common good, and in our defense of rights, all people must be considered in their integral humanity.

For reasons stated above,

- We invite civil society to join efforts to defend human, collective, and environmental rights, as well as fundamental freedoms from an intersectional, inclusive, all-encompassing, effective, and multicultural perspective.
- We demand from States their commitment to the respect, protection, and defense of human rights and of Mother Earth, ensuring the full and effective participation of civil society to strengthen the democratic space in countries, and to promote the collective interest to eradicate impoverishment, inequality, and corruption.
- We require multilateral organizations to strengthen and democratize the spaces of participation for civil society, respecting the agendas of organizations. We request that they act with due diligence to respond promptly to human rights violations that occur in the region and ensure intersectional and diverse representation in such spaces.
- We denounce that private, national, and transnational companies generate impacts on the rights of individuals, collectives, and Mother Earth, and we demand that they establish effective and suitable mechanisms that respect rights.
- We call on the media to ensure that their work in informing and educating public opinion is framed with respect for the rights of individuals and Mother Earth to combat the spread of disinformation, hate speech, and all expressions of violence, with the aim of strengthening democracy.
- We invite international cooperation and civil society funders to reflect on how cooperation agendas are built, as well as establish practices to democratize access to philanthropic resources and private social investment.

Building on the legacy of defending human rights, we are convinced that there are opportunities to build a new reality for the region together and we salute all those involved; we continue to walk in memory of those who have preceded us.

Finally, we would like to invite you to RegionaR to participate in this space of dialogue and permanent reflection for the radical and sustainable transformation of our Latin America and the Caribbean.
